

**WARRANTY PVC-UE MASS COLOURED  
CELLULAR STANDARD CLADDING PROFILES  
INSTALLED IN CLIMATE ZONES WITH A SOLAR RADIATION LESS THAN 130 KLY/YEAR**

Subject of the conditions set out below, Deceuninck NV warrants to the purchaser who directly purchases from Deceuninck NV (hereinafter "Purchaser"), that the PVC-UE cellular products will correspond with their specification at the time of delivery.

SAVE AS EXPRESSLY PROVIDED IN THIS WARRANTY, DECEUNINCK NV DOES NOT PROVIDE ANY WARRANTY (WHETHER EXPRESS OR IMPLIED) AS TO THE QUALITY OF THE PVC-UE CELLULAR CLADDING PRODUCTS OR THEIR FITNESS FOR ANY PARTICULAR PURPOSE (EVEN IF THIS PURPOSE IS MADE KNOWN EXPRESSLY OR BY IMPLICATION BY DECEUNINCK NV) OR AS TO THE CORRESPONDENCE OF THE PVC-UE CELLULAR CLADDING PRODUCTS WITH ANY DESCRIPTION OR SAMPLE. NEITHER DOES DECEUNINCK PROVIDE ANY OTHER WARRANTY. SUCH WARRANTIES ARE HEREBY EXCLUDED TO THE FULLEST EXTENT PERMITTED BY LAW.

Notwithstanding the stipulations of this Warranty and subject to evidenced normal residential use, load and maintenance conditions, Deceuninck NV (hereinafter "Deceuninck") warrants to the Purchaser that,

- (1) for a period of ten (10) years from the date of original purchase, PVC-UE cellular profiles shall not crack, swell or corrode
- (2) for a period of ten (10) years from the date of original purchase, the colour of PVC-UE cellular profiles being exposed in climatologic conditions to less than 130 kLy/year of solar radiation, will remain almost unchanged it being understood that the contrast corresponding to scale 2/3 on the grey scale according to ISO 105/A03 is not exceeded. The contrast concerned must be determined on a clean surface.

If one of the above defects occur within the related warranty period, Purchaser shall immediately notify Deceuninck in writing and the Purchaser shall provide a description of the claimed defect, proof of purchase and of purchase date and of normal residential use, load and maintenance. If these conditions have not been complied with, the warranty shall not be applicable. Upon timely notification and in accordance with the above, Deceuninck will at its option and in Deceuninck's sole discretion either, (a) provide Purchaser with non-defective replacement PVC-UE product or (b) substitute the defective PVC-UE product with a product that is of comparable value and quality in the sole opinion of Deceuninck or (c) refund the portion of the purchase price paid by Purchaser for such defective product taking into account the depreciated value of the product (not including the cost of its initial installation).

Any replacement or substitute products provided will be covered under this Warranty only for the time remaining under the original Warranty period.

Deceuninck reserves the right to discontinue availability of any PVC-UE product at any time.

The replacement, substitution or refund of defective PVC-UE products is Purchaser's sole remedy under this Warranty.

Deceuninck will have no liability or responsibility to the Purchaser other than as expressly provided in subparagraphs (1) and (2) above.

Labour costs incurred in removing defective PVC-UE products or installing replacement or substitute products are NOT covered by this warranty. Any additional costs and expenses, such as shipping, delivery, installation, removal, and all other incidentals are not covered by the warranty and are expressly disclaimed.

Deceuninck can not be held responsible for: (1) improper installation of PVC-UE products and/or failure to abide by Deceuninck's manufacture and installation regulations; (2) use of PVC-UE products beyond normal residential use, or in an application not recommended by Deceuninck's guidelines and local building codes; (3) movement, distortion, collapse; (4) any act of God (such as flooding, hurricane, earthquake, lightning, etc.; non-exhaustive list), rebellions, civil wars, etc.; non-exhaustive list; (5) damage directly or indirectly caused by exposure to non-natural sources of heat or UV radiation, environmental condition (such as air pollution, mold, etc.; non-exhaustive list), or staining from foreign substances (such as dirt, grease, oil, inappropriate maintenance products or products that are not intended to come into contact with the PVC-UE products etc.; non-exhaustive list); (6) PVC-UE-products installed in climate zones with climatologic conditions above 130 kLy/year of solar radiation; (7) PVC-UE products installed in the French overseas departments and territories (referred to as the dom-tom); (8) improper handling, storage, improper use or neglect of PVC-UE-products by Purchaser or third parties.



No person or entity is authorized by Deceuninck to make any statement or representation as to the quality or performance of PVC-UE products other than as contained in this warranty and Deceuninck shall not be bound by any statement or representation. This warranty may not be altered or amended except in a written instrument signed by Deceuninck and Purchaser.  
This warranty is governed by Belgian law.

This warranty is issued by DECEUNINCK on 27/11/2013 and accepted by Purchaser.
